It is for the information of the public at large and the student community in particular that as on date, there are following 13 private universities established by the Acts/ordinance of the state Legislation:

- 3 **I.T.M. University**, **Gwalior** – 474 001

1. These universities are established under Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007 and therefore all the provisions of the said Adhiniyam shall be complied with by these private universities.
2. All private universities shall be governed by UGC (Establishment of and Maintenance of standards in Private University) Regulation, 2003 and by such other Rules/ Regulations as issued by UGC from time to time.
3. Private Universities are unitary in nature and can conduct courses in regular mode through its campus only.
4. They shall operate only in their territorial jurisdiction i.e. within the concerned state.
5. They cannot affiliate any college or institution for conducting course leading to award of its diplomas, degree or other certificates.
6. They cannot offer programmes through franchising arrangements with any other institutions including private coaching institutions even for the purpose of conducting courses through distance mode.
7. They can award only such degree as are specified by the UGC published in the official gazette.
8. No private university in M.P. has been permitted to establish off campus centres, off shore campus and study centre till date.
9. The Private universities can run only such courses which have its relevant ordinance (of that particular university) duly published in the official Gazette of M.P.

The students are sincerely advised not to take admission in the unapproved study centres, off campus centres, Franchisee Institutions, Colleges/ Institutions claiming to be affiliated with Private Universities of M.P.

In case of violations of any of the above is noticed it should be brought the notice of the Chairman/Secretary of M.P. Private Universities Regulatory Commission, along with the relevant supporting documents for further necessary action.
